## **TOURNAMENT CONDITIONS:**

1. Matches shall be played at the time and on the court specified.
2. Matches commence at 9.00am on Saturday and Sunday.
3. Players must be in attendance 15 minutes prior to starting time.
4. This is a Team event which shall consist of 3 men and 3 ladies in Grades A, B, C & D (subject to entries). **Players must be listed on the entry form in order of merit.** Part teams will be accepted only if payment is made for a full team. Individual entries will be accepted (note: do not send fee as this will need to be paid to the team to which you are allocated). Part teams will be filled by the BVASA if possible
5. The BVASA reserves the right to re-grade entries.
6. Matches will consist of 3 mens doubles, 3 ladies doubles and 3 mixed doubles. Games to be played to 21 points, no advantage.
7. All players must have reached the age of 35 by the 7<sup>th</sup> March 2026.
8. All players must be financial members of their respective State Veterans Association. Interstate players will be required to provide evidence of this before play.
9. Only non-marking shoes permitted.
10. Feather shuttles will be used for all Grades.
11. Team entry fees and all other relevant fees must accompany the entry form.
12. The Rules of Badminton as laid down by the BWF will apply unless otherwise decided by the BVASA Committee.
13. Substitutes may be allowed at the discretion of the BVASA Committee. Substitutes must be eligible in all ways to compete in the relevant grade.
14. Players take part in the tournament at their own risk.
15. The above is subject to change at the discretion of the Committee.
